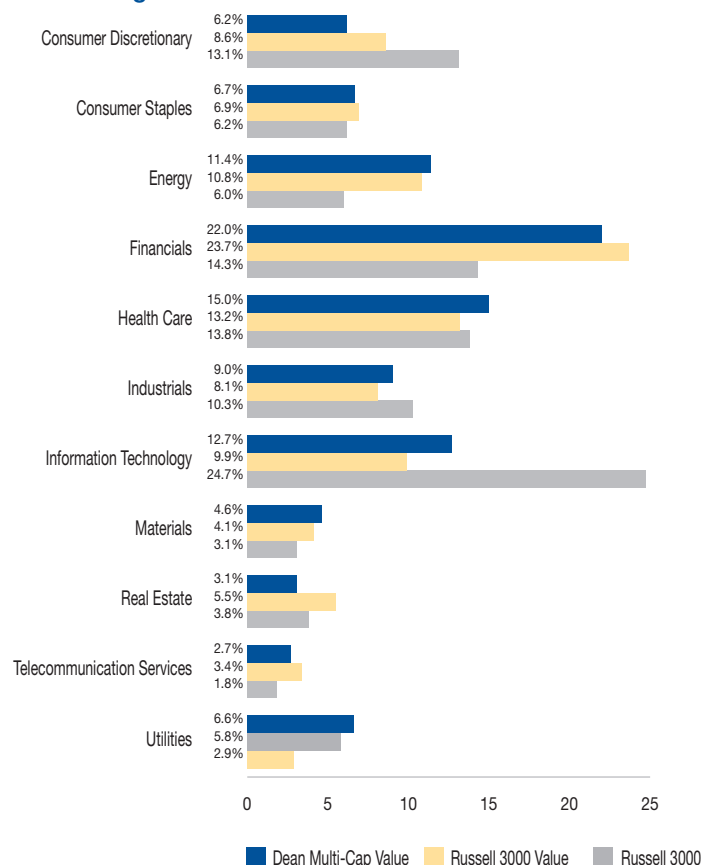

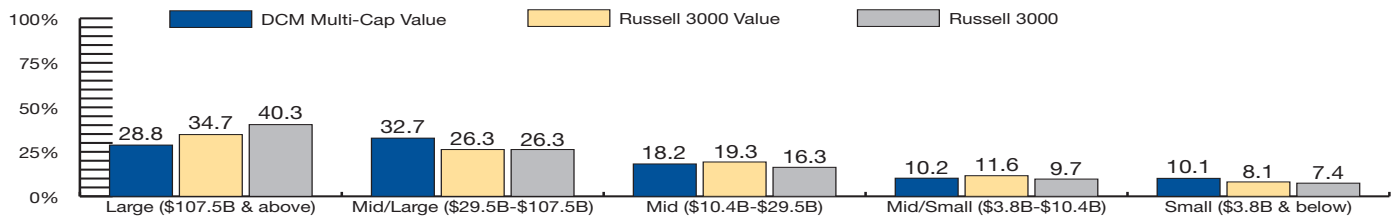
Kevin E. Laub, CFA

Market Capitalization^{2,4}

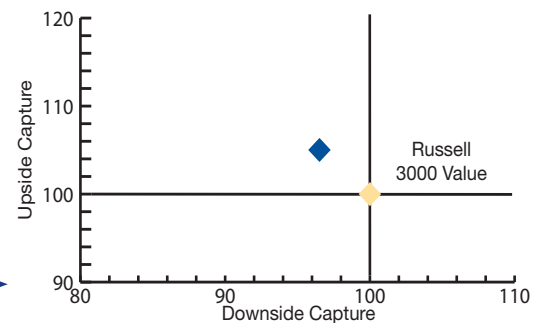
