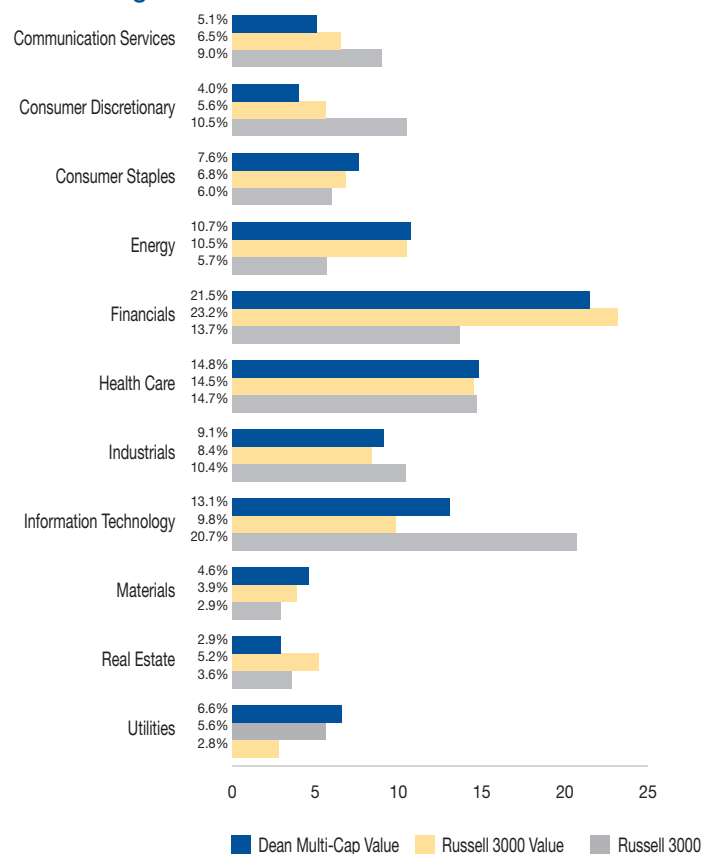

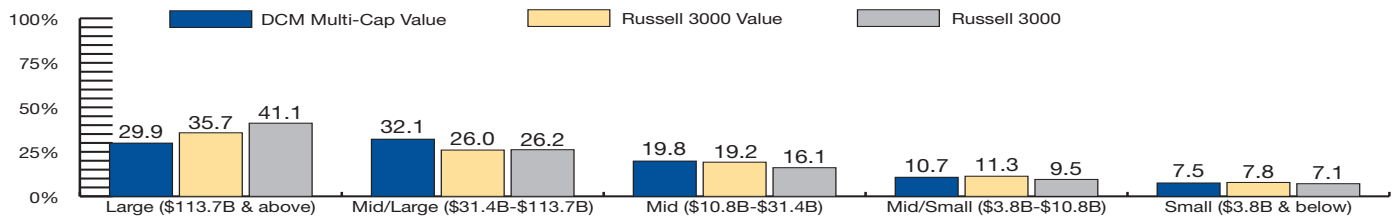
**Kevin E. Laub, CFA**

**Market Capitalization<sup>2,4</sup>**

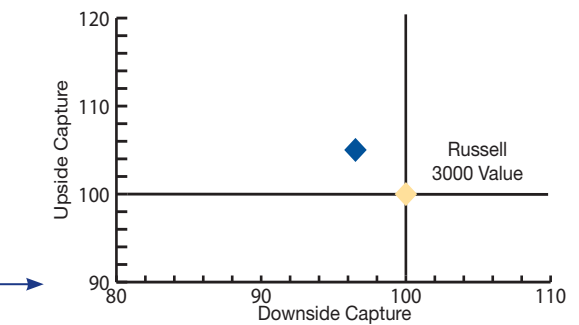
